Safeguarding policy statement

At Aretians RFC, safeguarding is everybody's responsibility. We are committed to creating an environment where children and young people feel safe, welcome, valued and heard. We believe that every child has the right to enjoy rugby in a safe, positive and inclusive environment. Guided by the Core Values of Rugby: Teamwork, Respect, Enjoyment, Discipline and Sportsmanship, we will work together to promote wellbeing, prevent harm and respond appropriately whenever concerns arise. The welfare of children is paramount in all decisions and actions taken by the Club.

Purpose

This policy sets out the Club's commitment to safeguarding and promoting the welfare of children involved in rugby union. It applies to everyone involved in the Club, including players, coaches, volunteers, officials, committee members, parents, carers and spectators. For the purposes of this policy, a child is anyone under the age of 18.

Safeguarding framework

Aretians RFC adopts and will comply with RFU Regulation 21, the RFU Safeguarding Children Policy, the RFU Safeguarding Handbook and relevant legislation and statutory guidance. These documents provide the detailed safeguarding standards, procedures and requirements that underpin this policy.

What we ask of our members:

- Treat everyone with dignity; value diversity; listen to children; and encourage everyone to share good practice and raise concerns.

Enjoyment

What we ask of our members:

- Help make rugby enjoyable; encourage participation; support positive experiences.

What the club will do:

- Create a safe, welcoming environment; prioritise safeguarding and welfare; celebrate positive contributions.

Discipline

What we ask of our members:

- Follow policies and codes; take responsibility; raise concerns.

What the club will do:

- Respond appropriately to concerns; apply procedures fairly; take action where risks arise.

Sportsmanship

What we ask of our members:

- Demonstrate honesty, fairness and kindness; be a role model; challenge poor behaviour.

What the club will do:

- Promote rugby values; support volunteers and officials; maintain a safe environment.

Listening to children and young people

We are committed to listening to children and young people, taking their views seriously and supporting them to speak up when something concerns them.
